The association "La casa di Toti" Onlus announce an international competition to select the designers who will design some ecodesign external furnitures split in three categories (seats, leisure area, totem).

Goal of the Association is the realisation of a co-housing where the special guys will live. The residence will be build near to the Toti family's hystorical house, yet used as a holiday house for many years. Here the guys will learn the independence value, offering to the hotel guests all the needed services: reception, check-in and check-out management, food & beverage, rooms cleaning, gardening, etc.

La casa di Toti will be the first Sympathetic Hotel in Sicily, managed from disabled guys helped by tutors.

The competition will be based in the extraordinary Mediterranean garden which is the setting of hystorical villa of '700, on the Iblea territoy.

Theme description

The idea of the competition was born from the collaboration between architects and sicilian company working in the building and ecodesign industry. The goal is to construct three furniture elements for the outdoor areas of the hystorical house, one for every competition categories:

1. Seats

Is expected the realisation of two seats, small sized, that can be used in summer and replaced during the winter season.

2. Leisure area

Is expected the realisation of a bar counter which it remains outdoor for the whole year. All the systems for the proper operation (idric, electric and illuminating system) must be integrated with the design.

3. Explicative totem

Is expected the realisation of a totem that explains about the spaces of the sympathetic hotel and about the garden. It will must contain the story of the Association "La Casa di Toti" Onlus and will may have an high interaction level from the user.

The ecodesign objects will must satisfy **durability**, **affordability**, **availability** and **flexibility** parameters.

The designed elements will must be realised only using the material described under this section, or in some of their combination. Obviously will be necessary consider their characteristics and their maintenance costs during their lifetimes. Moreover the project will must consider the element construction time that it's must be lower than a week.

The materials

The materials which can be used must exclusively be:

- Straw
- Bamboo
- Cardboard
- Terracruda

However it is allowed to use a small part of other materials (wood, metal elements, strings or whatever is considered necessary) to support the main materials. By simplify the material selection, after the registration the contestant will can download all the indispensable material to best understand the usable materials.

Partecipation requirements

Can take part to the competition: students and professionals, alone or in a team. The association encourage the attendees to assemble multidisciplinary team which include artists, designers, architects, engineers, etc.

All the team members must be adults and they will not



have thirty-six (36) years old until the 31th on December 2019.

Every designer or designer team member can send only one proposal.

Deadline to proposals reception

The deadline to send the proposal is the 1st on December 2019 at times 23:59.

The proposals sended after the deadline will not be accepted.

Design guidelines

In the last years the Desing planning obtain a value more social and anthropological, it develops the "Design for Health" concept, in other words the design and realisation of elements, common as well, wich point to the differences both physicals and cognitives of the users. Starting from the definitions of "user-centred design" and "design for all" seems clear that the attention for physical and psychic needs of user must be central, as well as the necessity to strengthen objects which are not prejudiced and bring back the user into the society. The studies show that genetic syndrome affected people, in example Kanner syndrome or autism, the emotional factor represent the key to restore the relation from person and surrounding location. For the design, working on this relationship, means to realize that planning solutions which achieves a best emotional impact through material, shape, colours. Autistic subjects tend to process sensorial informations in a different way compared to the other people, tending to be hyper or ipo-sensitive to external stimuli such as light, sound, temperature and objects surface.

For this reason the competition propose itself to sensibilize about social utility of the design, centering in the design process ethical and environment themes.

The designed furnitures must satisfy the wellness request of garden users, guest and staff of simphatetic hotel, in terms of visual, olfactory and tactile comfort and the environmental sustainability, using natural materials. The projects must also respond to safety requirements related to stability, fire resistence, mainteneance and fruibility thinking also to the disabled.

Selection process

Furnishing elements will be selected by a Technical Committee and by a Honour Committee on the base of:

• The creative answer about the competition theme and the right selection of the materials;

- The originality, the coherence and the clarity of design idea and the potential interaction with the users and the future staff;
- The project contribute to technical and artistic innovation of the ecodesign elements;
- The feasibility and the accuracy compared with the budget and the timing setted.

The short-list of first 15 furnishing elements (5 per each category) will be publish on 10th of December 2019 on the website: www.lacasaditoti.org

Project oversize and realisation

The construction of the three winner furnishing elements of the competition will be realised by designers themself, with an help of technical staff and local companies.



Registration method

Application submissions

The application must be sended online to the email adress **consegna@lacasaditoti.org**. It must be sended until the peremptory term of 1st of December on 23:59 local time (UTC+1).

The candidacy documents must be sended in 2 PDF FILE named (A,B) and 1 JPEG FILE named (C) with the following contains:

A – 1 PDF file at most 3 sheets, A3 landscape format, max weight 5 MB, that contains:

- Project title (it must not be specified the name of the designer/s);
- A text at most 500 words with the concept description of furnishing element;
- Plan, elevations, sections and details useful to better explain the furnishing element;
- At least a view (render or sketch or perspective or axonometric projection) that explains the furnishing element;
- Other possible schemes, sketch, indication;
- Material cost valuation;
- Construction process.

N.B. Make sure of all the drawings can be read in A3 format and they are numbered per page with the project title in the first page.

$B-1\ PDF$ file at most 1 sheet A4 portrait, which identify the design team or the single designer, that contains:

Project title, name of the designer or team members, birth date, short description of designer or team (500 characters excluding spaces).

The contacts of the designer or about the team leader (address, telephone number, e-mail, website, social network).

C-1 JPEG file 1200 x 1000 px landscape, to promote the project:

The postcard will be use as illustrative picture project and will be publish on the social media and on the contest website.
